## UPDATES

### Income Assistance Information

On March 17, 2021, **the Province of BC announced** a permanent increase to income assistance and disability assistance rates and the first-ever increase to the senior's supplement. Starting with payments issued in April 2021, individuals on income assistance and disability assistance will automatically receive the increase.

Indigenous Services Canada is updating the regional policy rates to remain comparable to the Province of BC.

**Effective April 2021**, the ISC rates are as follows:

- Members who are already in receipt of regular Income Assistance, the Persons with Disabilities benefit (PWD) and the Persons with Persistent Multiple Barriers benefit (PPMB) assistance will be entitled to an increase of \$175/month per adult (\$350 for couples) to their basic needs allowance starting in the month of April 2021.
- Comforts Allowance (for people in special care facilities) will increase by \$20 to \$115. (At this time, there is no increase to the Comforts Allowance for PWD clients.)
- Seniors Supplement increase is \$50 per recipient.

## VACCINE INFO UPDATE

### COVID-19 vaccines: get the facts

The Government of Canada has developed a **fact sheet** to help answer questions and dispel myths on the COVID-19 vaccinations. Common questions are answered, including questions related to side effects, vaccination safety and public health measures.

### FROM OUR PARTNERS

In case you missed it, the British Columbia Association of Aboriginal Friendship Centres (BCAAFC), Métis Nation BC (MNBC), the First Nations Health Council (FNHC), the First Nations Health Directors Association (FNHDA), and the First Nations Health Authority (FNHA), **issued a news release** responding to questions posed by some members of the public asking why Indigenous people are a higher priority for receiving a COVID-19 vaccine in British Columbia (BC). The response may help support conversations with your members and any inquiring neighbouring populations.

“From the outset, the vaccine rollout to Indigenous people in BC was based on recommendations from Canada’s National Advisory Committee on Immunization, said Richard Jock, FNHA’s Chief Executive Officer. “In considering potential at-risk groups, the advisory committee identified Indigenous people as high risk and therefore considered a high priority to receive an initial dose of the COVID-19 vaccine.”

FNHA Acting Chief Medical Officer, Dr. Shannon McDonald said, “Access to acute care within 2.5 hours was a key element and informed the decision to provide vaccines to remote communities first and work our way inward. As COVID-19 clusters were identified, the FNHA directed vaccine supply to those affected communities.”

The following factors formed some of the basis of the National Advisory Committee on Immunization recommendations:

- Racialized and marginalized populations in Canada have been disproportionately affected by COVID-19.
- Systemic barriers to supportive care for COVID-19 also exist in urban settings due to factors such as poverty, systemic racism and homelessness.
- The risk of transmission is especially high in remote or isolated First Nations communities where physical distancing and other infection prevention and control measures are challenging.
- Adults living in First Nations, Métis, and Inuit communities, where access to health care may be limited and infection can have disproportionate consequences, should be prioritized to receive initial doses of the COVID-19 vaccine.

The existence of anti-Indigenous racism within the provincial health care system has been well documented and cannot be ignored. Indigenous-specific racism can lead to hesitancy in seeking care, negative experiences at the point of care, inequitable medical treatment, physical harm and even death for BC’s First Nations, Métis, and Inuit people.

Existing data shows the extent to which Indigenous people are disproportionately affected with a much higher risk of hospitalization and death due to the transmission of the COVID-19 virus than the non-Indigenous population in BC. ### Infrastructure Canada Call for Applications for the new Green and Inclusive Community Buildings Program

With many communities ready to turn the page on COVID-19 and look to recovery, a new infrastructure initiative may be of interest.

Infrastructure Canada is currently accepting applications for retrofits and new building projects for community buildings. Applications are being accepted



on an ongoing basis for projects under \$3 million and until July 6, 2021 at 23:59 PDT for projects from \$3 million to \$25 million.

The Green and Inclusive Community Buildings (GICB) program aims to build more community buildings and improve existing ones – in particular in areas with populations experiencing higher needs – while also making the buildings more energy efficient, lower carbon, more resilient, and higher performing. This five-year \$1.5 billion program will support green and accessible retrofits, repairs or upgrades of existing public community buildings and the construction of new publicly-accessible community buildings that serve high-needs, underserved communities across Canada.

The GICB program supports the first pillar of the **Strengthened Climate Plan** by making it easier for Canadians to improve the places in which they live and gather, including by cutting pollution (e.g. reducing GHG emissions, increasing energy efficiency, building resiliency to climate change and encouraging new builds to net zero standards), making life more affordable and supporting thousands of good jobs.

Infrastructure Canada invites municipal or regional governments, public sector bodies, not-for-profit organizations, provincial or territorial governments and Indigenous recipients to apply for funding for eligible projects.

\$150 million has been set aside for Indigenous applicants undertaking projects that will serve Indigenous populations and communities.

## Emergency Funding Boost Supports Student Success In The North

Students attending post-secondary institutions in northern British Columbia have access to emergency assistance funding to help them cope with financial pressures caused by COVID-19.

Since March 2020, post-secondary institutions in northern BC have received a combined total of \$1,283,500 to assist students, including Indigenous students, who are experiencing an unexpected financial emergency that may affect their ability to complete

## FIRST NATIONS WELL-BEING FUND

First Nations throughout BC can now **apply for funding to promote well-being, improve quality of life for community members on and off reserve**, and find solutions to poverty in their communities.

Funding is offered through two streams: community projects and planning. The community projects stream provides up to \$35,000 for a single First Nation, \$70,000 for two First Nations and \$105,000 for regional applications of three or more partnering First Nations.

Applications will be accepted through the **First Nations Public Service Secretariat** until 11:00 p.m. (Pacific time) on Sunday, May 30, 2021.

their studies and handle expenses, especially those related to COVID-19.

The **non-repayable emergency assistance** can be used to help with a broad range of costs, including living expenses, food, travel, portable computers and other supports for students who are returning to campuses for 2021-22. This emergency funding is part of \$9 million invested since March 2020 to help BC post-secondary students.

Students who attend one of BC's 25 public post-secondary institutions, as well as the Native Education College and students enrolled in post-secondary programs at Indigenous institutes, may apply to access these funds by contacting their school's financial aid office or Indigenous student service centre.

## Still Time to apply for the BC Recovery Benefit

The **BC Recovery Benefit** (the benefit) is a one-time direct deposit payment for eligible families, single parents or individuals. Benefit eligibility is based on net income from your 2019 tax return. Members must apply before June 30, 2021 to receive the benefit.

## BENEFIT RATES

The amount you're eligible for will be automatically calculated based on your net income.

Applicants must provide 2019 income tax data to receive the benefit.

## FAMILIES AND SINGLE PARENTS

- \$1,000 for eligible families and single parents with a net income of up to \$125,000
- Reduced benefit amount for eligible families and single parents with a net income of up to \$175,000

The benefit defines a family as an individual and their spouse or common-law partner, unless they are **separated**. Both people must be residents of BC on December 18, 2020.

The benefit defines a single parent as an individual who is the principal caregiver to at least one child. A child is someone under the age of 19 on December 18, 2020 who would not be eligible for the benefit on their own.

## INDIVIDUALS

- \$500 for eligible individuals with a net income of up to \$62,500
- Reduced benefit amount for eligible individuals with a net income of up to \$87,500

## BC Unveils New Programs to Help Corporations Recover from the Financial Impacts of COVID-19

As part of BC's Economic Recovery Plan, the Ministry of Finance has opened applications for two new programs to help corporations recover from the financial impacts of COVID-19.

The BC Increased Employment Incentive is a one-time refundable tax credit for employers which encouraged the creation of new jobs for BC workers or increases in payroll for existing low- or middle-income employees in the last quarter ending December 31, 2020. The tax credit is calculated at 15% of the amount that the employer's eligible remuneration for the last quarter ending December 31, 2020 exceeds the employer's eligible remuneration for the quarter ending September 30, 2020.

The BC PST Rebate on Select Machinery and Equipment is a temporary provincial sales tax (PST) program that acts like a refund but is separate from the existing PST Refund process. Under this temporary program, corporations can apply to receive an amount equal to the PST they paid between September 17, 2020 and September 30, 2021 on qualifying machinery and equipment.
